(Please read carefully before signing)

1. These terms and conditions are made between Jester Entertainment and (Please insert name) (hereinafter called 'the Client').
2. These terms and conditions shall constitute an agreement for the supply of services by Jester Entertainment to the Client and shall be deemed to have been accepted by the Client upon acceptance of the first lesson by the Client via Jester Entertainment.
3. The duration of this agreement shall be on-going from the date of acceptance of the Client by Jester Entertainment unless terminated in accordance with the provisions below.
4. During the period of agreement Jester Entertainment will use their best endeavours to provide good quality tuition to their Clients and/or their children.
5. The Client will receive an invoice at the beginning of every month, for services received in arrears, and will be required to pay that invoice within a specified time of receipt. If that invoice is not paid within the specified time, the Client accepts that a 'Late Payment' charge of £10 per month will be added to their bill. Jester Entertainment reserves the right to suspend lessons at any time if payment is not made.
6. In the event of a cancellation of a lesson by the teacher, Jester Entertainment will try wherever possible to arrange another time and day. If this is not possible, the lesson will not be charged for. If the Client cancels a lesson, we will need 24 hours notice in order for the Client not to be charged for the lesson. If less than 24 hours notice is given, the decision lies with the individual teacher whether they wish to charge or not.
7. Jester Entertainment will give the Client at least 1 month's notice of any rise in fees.
8. This agreement may be terminated:
 - a) By the Client giving not less than 1 month's notice in writing to Jester Entertainment or,
 - b) By Jester Entertainment giving to the Client not less than 1 month's notice in writing except in the case of the occurrence of one or more of the Specified Events set out in clause 9 in which case summary immediate termination shall be reasonable.
9. The Specified Events shall mean any of the following:
 - a) Gross misconduct or abuse of the Tutor.
 - b) Abuse of any child during the lesson.
 - c) Constant failure to submit any payment for tuition within the time limit designated
